The SECOND AMENDMENT TO MASTER DEED MADE THIS ^m5 day of March, 1987, by
ELM-HILL INCORPORATED, a New Jersey Corporation, having an office at 50 Route
46, Parsippany, New Jersey (hereinafter referred to as "Sponsor").

WITNESSETH:

WHEREAS, the Sponsor has heretofore recorded a Master Deed for Tempe Wicke
Condominiums, a Condominium, Morristown, New Jersey 07960, which Deed is dated
September 13, 1985 and was recorded with the Office of the Clerk of Morris
County on September 17, 1985 in Deed Book 2815 at Page 522 et seq., and

WHEREAS, the Sponsor reserved for itself, pursuant to Paragraph 22 of said
Master Deed, the right to amend said Master Deed; and specifically to transfer
a garage unit assigned to one apartment unit to another apartment unit, and

WHEREAS, the Sponsor desires to assign Garage A, an unassigned garage, to
Condominium Unit 5 and to reallocate the percent of common interest by
increasing the common interest of Unit 5 from 5.7497% to 5.9497%.

NOW, THEREFORE, the Sponsor does hereby declare, publish and establish
this Second Amendment to Master Deed for Tempe Wicke Condominiums, a
Condominium, by amending Exhibit C entitled "DESIGNATION OF APARTMENTS,
GARAGES AND PERCENTAGE OF COMMON ELEMENTS" only as to Unit No. 5 to read as
follows:

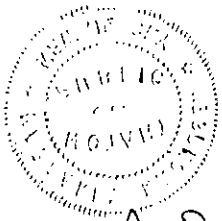
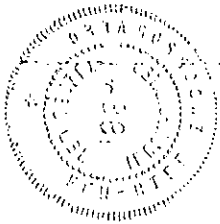
